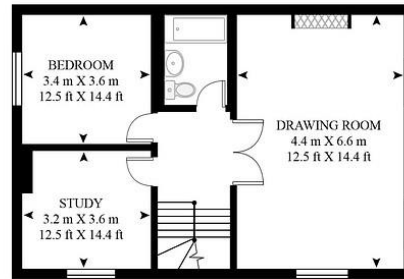
APPROXIMATE GROSS INTERNAL FLOOR AREA 1872 SQ.FT (174 SQ.M)
